CREDIT TERMS AND CONDITIONS

1. All new accounts are to be credit approved. No C.O.D. deliveries or services provided.
2. Credit terms are net 30 days for all products and services unless other terms are negotiated.
3. A statement of account will be mailed on a monthly basis to all accounts with a balance over 30 days. Please notify G. Nase and Son, Inc. immediately at (215) 721-3800 if an error exists on your account.
4. Thirty (30) days after delivery a finance charge with a periodic rate of 1.5% (an effective annual percentage rate of 18.00%) will be charged on all overdue accounts. The minimum monthly finance charge is \$1.00.
5. Continued delinquency will result in all credit privileges being revoked and collection procedures will be started.
6. The customer is responsible for all costs of collection.
7. A service charge of \$25.00 will be charged for all returned checks—\$50.00 for second return of the same check.
8. The following special discounts may be applicable to your account:
 - 2 cent per gallon senior citizen discount for customers 65 years or older—residential accounts only
 - 3 cent per gallon discount for cash or check payment within 10 days of delivery
 - 1 cent per gallon discount for credit card payment within 10 days of delivery
 - Volume discounts
 - Farm discounts
